Family, Individual and Berth Holder members can elect to pay by monthly direct debit.

The children aged 8-17 of family members can apply to join the very popular junior / LSTA training scheme, but should first check that places are available – applications must include an LSTA waiting list form (see <http://www.lsta.org.uk/jointhecadets>), and applicants will be put on the waiting list. (** - junior members aged over 16 or over at the date of a general meeting may vote.)

Distance discount - for family and individual members only, a "distance discount" is offered - 50% reduction in your membership subscription if your principal residence is 50 or more miles radius (roughly the west side of Edinburgh) from the Club. Please note that distances are calculated on a straight line basis, and you can use e.g. www.freemaptools.com to calculate whether you qualify. No reduction applies to dinghy berthage, if applicable.

DISCOUNT CARD - new Family, Individual, Berth Holder and Junior members will receive a discount card, entitling them to receive discounts (typically 10%) from many of the businesses in the marina, and the Largs area. Presently (Dec 2018), these include LYH hoist services, Largs Chandlers, Saturn Sails, DDZ, Scotsail, C&C Marine, Mast and Rigging Services, Equipage, Scotts, Bosun's Table, Flamingo Yacht Charter, Sailaway Scotland, Haven Spa, Optimal Physio, Interiors Afloat, Stately Interiors, and the Old Rectory B&B.

* - **Berth Holder** - applies to owners of keelboats and power boats, based anywhere i.e. it is not restricted to boats berthed in Largs Yacht Haven. Membership is per boat, and includes participation in the cruising group (sail and power, summer and winter), and social rights. **Excludes** dinghy sailing and berthage rights, cadet rights, and vote.

** - **Crew Member** - a member who crews only. Can use clubhouse only immediately before or after Club sponsored racing.

House Members - can be keelboat or motor boat owners, IF their boat is NOT kept in Largs Yacht Haven for part or all of the year. **Excludes** dinghy sailing and berthage rights, cadet rights, and vote.

Joint House Member includes spouse or partner, who may use the Clubhouse separately. Otherwise as above.

Newsletters by post - the club now communicates mainly by e-mail, and also uses e-mail for membership administration. If you do not give an e-mail address, you must take a £8 supplement to cover postage and admin costs.

Membership, and Data

New, more stringent Data Privacy and Protection regulations ("the GDPR") came into force on 25th May 2018, and we require all new and current members to signify their consent (or otherwise) to the matters below. The key points are that:

- we will NOT share your information with any third party without your specific consent
- you now have to positively opt IN to certain uses of your data.

1. Membership conditions

By applying for membership, and continuing your membership, you consent to:
