Club members are asked to note that it is a **requirement of the Licensing Laws that guests must be signed in to the clubhouse on all occasions.**

To add **dinghy sailing rights**, berth holder members can upgrade to **individual** (which is self-explanatory) or **family membership**, which entitles all the family (including children under 25) to use the club, and children aged 8 to 17 to join in the very popular cadet training scheme. # Largs Sailing Club

## Membership, and Data

New, more stringent Data Privacy and Protection regulations ("the GDPR") came into force on 25th May 2018, and we require all new and current members to signify their consent (or otherwise) to the matters below. The key points are that:

- the information you provide in your membership application form, or on WebCollect, will be used solely for dealing with you as a member of Largs Sailing Club
- we will NOT share your information with any third party without your specific consent
- you now have to positively opt IN to certain uses of your data.

#### **1. Membership conditions**

By applying for membership, and continuing your membership, you consent to:

- **storage and processing of member's data** - your data being stored on a computer database (presently WebCollect)
- **Club Management Rules** - you, your dependants, and any guests on Club premises, will abide by the Club Management Rules, which are available on our web site - see <http://www.largssc.co.uk/club/publications>, or click [here](#)
- **dinghy park rules** - members with boats in our dinghy park will abide by section 10.3 of the Club Management Rules
- **insurance whilst racing** - when racing, boats must have third party insurance to the value of at least £2,000,000.00
- **communication with members** - our normal method of communications with members is by e-mail. Members not giving at least one valid e-mail address per membership must pay the supplement (presently £8) for communications by post.

#### **2. Date of birth**

Older members may give their date of birth, but we require **all members under 25 on 1st January** (the limit for junior membership) in the subscription year (Jan-Dec) to give their date of birth. Also, we need to know the parent or guardian of members under 16, please.
